

PETITION FOR RECALL

TO THE HONORABLE Nevada County Board of Supervisors: Pursuant to the California Constitution and California election laws, we the undersigned, registered, and qualified electors of the District 4, County of Nevada, California, respectfully state that we seek the recall and removal of Sue Hoek holding the office of Supervisor in District 4 in Nevada County, California. We demand an election of a successor to that office. The following Notice of Intention to Circulate Recall Petition was served on December 14, 2021 to Sue Hoek, Supervisor.

TO THE HONORABLE Sue Hoek, Pursuant to Section 11020 of the California Elections Code, the undersigned, registered qualified voters of the District 4, County of Nevada, State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Supervisor in the District 4, County of Nevada, State of California, and to demand an election of a successor for that office. The grounds for the proposed recall are as follows:

- 1) Concealed facts which were known or which should have been known to her through reasonable diligence. She neglected her constituents' warnings about the dangers of excess government which have resulted in loss of life, liberty, and property. She enabled crimes against humanity and censored public comments. She violated the oath of office, Brown Act and wasted millions of taxpayer dollars without financial impact reports.
- 2) Voted to violate citizens' privacy and other rights through "Contact Tracing of Citizens" by unscreened and questionable data "Tracers" from "Rapid Trace LLC dba Over the Ridge LLC". "They will provide Local Health Officer Isolation and quarantine guidance... referrals..." (Res. 21-460)
- 3) Neglected citizens' requests to immediately terminate department officers Glennah Trochet, Ryan Gruver and also terminate the Health Director Dr. Scott Kellerman for his public statement and gesture threatening to shoot/kill unmasked citizens'. (10-11-2021)
- 4.) Failed to re-open Nevada County. Promoted lockdowns, prescribed untested medical procedures, omitted use of life saving therapeutic medications, neglected natural immunity, increased county liability and directly violated religious freedoms and individual liberty.
- 5) Voted for U.A.S. Unmanned Aircraft Systems (Drones) to perform unconstitutional warrantless searches which violate privacy, due process and property rights. (SR 21-0635). The answer of the officer sought to be recalled is as follows: This recall is divisive, expensive and unnecessary. It will cost District 4 taxpayers up to \$250,000, money better spent on fire safety, schools and supporting local businesses. This seat is up for election in June of 2022 where voters will have the opportunity to vote in a regular election for the candidate of their choice. // The petition makes claims that are false and misleading. The County has a duty to follow the rule of law in its implementation of public health mandates. We have done so while providing unprecedented support to local businesses, non-profits, and cultural institutions to help them survive this pandemic. This BOS has succeeded in building low-income housing, expanding broadband, doubling wildfire vegetation management; ensuring fiscal stability while expanding mental health services, upgrading roads, coordinating with our town and cities, supporting legal cannabis while increasing enforcement against illegal grows, and providing comprehensive constituent assistance. // This recall attempt divides the community at a time when we need more cooperation and unity.
